- The Notice of Postal Ballot / E-Voting (Notice) is being sent to the members, whose names appear in the Register of members / beneficiary position maintained by the depositories as on close of business hours of Friday the April 07, 2017 ("Record date") and voting rights shall be reckoned on the paid-up value of shares registered in the name(s) of the member(s) / Beneficial Owner(s) as on the same date. A person who is not a member as on the Record date should treat this Notice for information purpose only.
- There will be one Postal Ballot Form / e-voting for every folio no. / Client id no. irrespective of the number of joint holders. In case of joint holding, the 2
- Postal Ballot Form should be completed and signed by the first named member and in his absence by the next named member.

  Voting rights in the postal ballot / e-voting cannot be exercised by a proxy. However, corporate and institutional members shall be entitled to vote through their authorised representatives with a proof of their authorisation.

- In compliance with the provisions of Sections 108, 110 and other applicable provisions, if any, of the Companies Act, 2013 read with the Companies (Management and Administration) Rules, 2014 and SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, the Company is pleased to provide e-voting facility to all the members of the Company. The Company has entered into an agreement with Karvy Computershare Pvt. Ltd. (Karvy) for facilitating e-voting to enable the members to cast their votes electronically instead of dispatching Postal Ballot Form. E-voting is the 5. optional facility available to members.
- The members can opt for only one mode of voting either by postal ballot or through e-voting. If the member decides to vote through postal ballot, they are advised not to vote through e-voting and vice versa. However, envelopes containing Postal Ballot Form, if sent by courier or by registered post or by speed post at the expense of the registered member will also be accepted. #### 15. PROCESS FOR MEMBERS OPTING FOR E-VOTING

### In case of members receiving the Postal Ballot Form by e-mail:

- Launch internet browser by typing the URL: https://evoting.karvy.com.
- Enter the login credentials (i.e. User ID and password mentioned overleaf). Your Folio No. / DP ID No. / Client ID No. will be your User ID. However, if you (ii) are already registered with Karvy for e-voting, you can use your existing User ID and password for casting your vote. After entering these details appropriately, click on "LOGIN".

- After entering these details appropriately, click on "LOGIN". You will now reach password change Menu wherein you are required to mandatorily change your password. The new password shall comprise minimum 8 characters with at least one upper case (A-Z), one lower case (a-z), one numeric (0-9) and a special character (@, #, \$, etc.). The system will prompt you to change your password and update your contact details like mobile number, email ID etc. on first login. You may also enter a secret question and answer of your choice to retrieve your password in case you forget it.
