{ DISSENSION IN CONGRESS } LEADERS HOLD DINNER MEET

G-23 demands inclusive leadership

NEW DELHI: The Congress was mired in dissension on Wednesday as a group of senior leaders demanding internal reforms held a significant show-of-strength over a dinner meeting, even as the party's leadership appeared to move towards trying to stem the turmoil after humiliating defeats in five state polls.

The meeting of the so-called G-23 (group of 23) leaders saw the attendance of five former chief ministers, and at least eight former Union ministers, among others. At least five sitting members of Parliament were part of the discussions, during which the leaders demanded that the Congress leadership "initiate dialogue with other like-minded forces to pave the way for a credible alternative for 2024", according to a statement released after the meeting.

The leaders — the note was undersigned by 18 — also said they believed "the only way forward is for the Congress to adopt the model of collective and inclusive leadership and decision-making at all levels".

Leaders aware of developments said that the Congress leadership informally reached out to at least two G-23 members earlier in the day, suggesting discussions on the future of the party — the first sign of an attempt to mend the rapidly deteriorating ties between leaders loyal to the Gandhi family and those demanding

internal elections.

It was unclear whether the G-23, a group of 23 leaders who first hit the headlines in 2020 when they wrote to Congress chief Sonia Gandhi demanding reform, would take up the offer. But two Congress functionaries indicated that there was a possibility of a meeting between party chief Sonia Gandhi and G23 leader Ghulam Nabi Azad soon. Former minister Mani Shankar Aiyar was a surprise addition during the meeting at Azad's residence on Wednesday night, and one of the leaders said on condition of anonymity that the strength of the group has swelled to 32. Another inclusion on Wednesday was Preet Kaur, an MP from Patiala and wife of former CM Amarinder Singh, who left the party last year after a bitter fallout.

One more unexpected attendee was Shashi Tharoor, who was part of the original 23 leaders who wrote the letter in 2020, but had not attended recent meetings of the group.

Aiyar and Tharoor did not respond to calls and text messages seeking a comment.

"We are no longer G-23, we are G-32... Five former chief ministers and at least 8-10 former Union ministers have all met. They are all adding up now. Everyone just wants to strengthen the party but the problem is no one wants to listen," one of the dissenting leaders said, asking not to be named.

The 18 leaders whose names were on the note, however, were Azad, Anand Shama, Kapil Sibal, Prithviraj Chavan, Manish

Tewari, Bhupinder Singh Hooda, Akhilesh Prasad Singh, Raj Babbar, Shankar Singh Vaghela, Aiyar, Tharoor, PJ Kurian, MA Khan, Rajender Kaur Bhattal, Sandeep Dixit, Kuldeep Sharma, Vivek Tankha, and Preet Kaur.

A lot of the attention was focused on former minister Kapil Sibal, who stirred a hornet's nest with an interview to the Indian Express on Tuesday, when he suggested that the Gandhi family should step away from the leadership of the party — a sentiment that other G-23 leaders had previously shied away from openly articulating. Since then, Sibal has faced backlash from Gandhi family loyalists, who have said he was hurting the party with his public criticism. Some leaders indicated that a resolution may be brought against him for publicly criticising the Gandhis.

The meeting was originally planned at Sibal's house but was later moved to Azad's residence. It lasted at least three hours and the expanded numbers — the group was atrophying members over the past year — might act as

a booster for their morale and demands.

"I don't know where Kapil Sibal belongs. For many years, he received so many benefits from the Congress. He never complained when he was a cabinet minister in the UPA government. But now when the UPA is not in power, he is finding the situation difficult and bad," the Congress's Lok Sabha floor leader Adhir Chowdhury said.

Protests against Sibal also grew in Chandni Chowk, his erstwhile parliamentary constituency. The Chandni Chowk City district Congress committee on Wednesday urged Congress president Sonia Gandhi "to immediately start a disciplinary enquiry against Sibal for trying to split the party". They also alleged that Sibal had neglected his constituency.

Internal reform has long been a point of intense dissension in the Congress but the dispute spilled out in the open after the party slumped to losses in five state assembly polls that concluded recently, losing one of only three states it ruled on its own.

With criticism mounting, both inside and outside the party, Sonia Gandhi has moved to revamp the party's structure in the five states by asking the respective state unit chiefs to resign, and on Wednesday, announced the names of five leaders who will individually look after the reorganisation — but critics say the changes are dwarfed by the scale of the reorganisation the Congress requires to take on the Bharatiya Janata

Party (BJP) in polls later this year.

The names of the leaders entrusted to carry out the reorganisation, ironically, may lead to more unrest within the party. "Even when they set up committees today to handle post polls, they are the same names like Jairam Ramesh, Avinash Pandey, Ajay Maken and Jitendra Singh," a second G-23 leader said.

The G-23 has repeatedly said that it is only interested in improving the Congress and doesn't mean to destabilise the party. But it remains unclear how receptive the party leadership is to the idea of internal reforms, though elections for the position of Congress president are set for August.

At the Congress Working Committee meeting on Sunday, several leaders backed the Gandhi family and refused to accept the offer of resignation by Sonia Gandhi. The CWC, instead, entrusted her to carry out "necessary and comprehensive" changes.

Senior Congress leader Mallikarjun Kharge alleged the G-23 leaders were attempting to break the party by continuing to hold meetings even after the CWC discussed all issues during its recent meeting. He said no one can weaken party president Sonia Gandhi as the entire Congress, "from the streets to the national capital", is with her.

"Sonia Gandhi is taking all steps that have been discussed at the CWC. If they (G-23 leaders) still speak like this, it means they are trying to break the party," Kharge added.

End social media's influence on electoral politics: Sonia

NEW DELHI: Congress chief Sonia Gandhi on Wednesday urged the government to end the "systematic influence and interference of Facebook and other social media giants" on electoral politics being used to "hack democracy".

Speaking in Lok Sabha, she called it an issue of paramount importance while referring to the rising danger of social media abuse. She added companies such as Facebook and Twitter were used increasingly to shape political narratives by leaders, parties, and their proxies.

Gandhi's comments came following an Al Jazeera article published on March 14 that said Facebook undercut the Opposition's influence on the platform ahead of the 2019 national elections and gave a distinct advantage to the ruling Bharatiya Janata Party (BJP). The article is based on an analysis of 536,070 political advertisements on Facebook and Instagram from February 2019 to November 2020. It assessed the influence of Facebook's political advertising policies on elections in the country.

Facebook (now Meta) and Twitter did not respond to a request for comment.

Without directly referring to the article, Gandhi said bias displayed by platforms such as Facebook has repeatedly come to the notice of the public.

"...global social media companies are not providing a level playing field to all parties." She added the blatant manner in which social harmony was being disturbed with the connivance of the ruling establishment is dangerous for democracy.

Gandhi said minds were being filled with hate through emotionally charged disinformation, sometimes by proxies. She added companies such as Facebook were aware of it and profiting from it. She referred to a growing nexus between big corporations, the ruling establishment, and social media giants.

Congress lawmaker Rahul

Gandhi also took a dig at the company. "Meta-worse for democracy," he tweeted.

BJP spokesperson Shehzad Poonawalla hit back calling the comments "the typical modus operandi" of the Congress. "Whether it is the EVM [electronic voting machines] or the Election Commission or blaming the people of India or now social media. Rahul Gandhi and Congress, just a few months ago, were hailing Twitter and other social media companies as bastions of free speech when the government came up with the intermediary guidelines to ensure they do not play super editors and remain neutral and operate as platforms to ensure a level playing field."

Facebook earlier came under scrutiny in 2020 when its India policy head, Ankhi Das, stepped down after details of her reluctance to censor hate speech surfaced. The controversy began following an August 14, 2020, report in the Wall Street Journal, which said Das intervened to stop Telangana BJP lawmaker T Raja Singh from being banned from the platform citing a possible fallout on the company's business interests. Last year, it was accused of allowing algorithms to amplify hate speech.

CONGRESS CHIEFS OF PUNJAB AND MANIPUR RESIGN

CHANDIGARH/IMPHAL: Congress leaders Navjot Singh Sidhu and N Loken resigned as state unit chiefs of Punjab and Manipur, respectively on Wednesday.

The move came a day after party president Sonia Gandhi demanded resignations from state chiefs of Goa, Manipur, Uttarakhand, Uttar Pradesh and Punjab, where the Congress suffered a drubbing in assembly polls.

5 Cong leaders to suggest changes in state units

NEW DELHI: Congress president Sonia Gandhi on Wednesday appointed five senior leaders to analyse the "post-poll situation" and suggest organisational changes in the five states that held assembly elections recently, people familiar with the development said.

The decision, underlining a sense of urgency, came a day after Gandhi ordered state unit chiefs in the five states — Uttar Pradesh, Punjab, Uttarakhand, Manipur

and Goa — to resign.

All India Congress Committee (AICC) general secretary Ajay Maken, who was also part of the party's Punjab poll campaign, has been entrusted to suggest organisational changes in the state unit. Many lawmakers from Punjab targeted Maken during their meeting with the party chief on Wednesday. Lok Sabha MP Jasbir Singh Gill told Gandhi that the ones on Punjab in-charge Harish Choudhary and Maken and alleged that the party tickets were "sold to undeserving candidates".

Former Union minister Jiten-

dra Singh will suggest organisational changes in the party's UP unit, while Rajya Sabha MP Rajani Patil, party's Rajya Sabha chief whip Jairam Ramesh and general secretary Avinash Pandey will analyse the electoral loss in Goa, Manipur and Uttarakhand, respectively, people cited above said. The Congress failed to win any of the five state polls, results of which were announced on March 10.

According to a communication from Congress general secretary KC Venugopal, these leaders will hold talks with "MLA candidates and important leaders" before sug-

gesting changes.

"These announcements show how the party high command is wasting no time to revive the party and also send a signal to the G23 that the leadership is taking necessary steps," a senior leader said requesting anonymity.

"The need of the hour is to bring in young faces in each state. We have to wait and see how the changes take place. But Sonia Gandhi's quick actions will send a message to Congress voters and workers that the party is serious about a revival," a leader considered close to the Gandhi family said.

सरकार बड़ा बदलाव करने की तैयारी में कैदियों की पहचान विधेयक को मंजूरी

कैबिनेट फैसला

नई दिल्ली, विशेष संवाददाता। केंद्र सरकार अब कैदियों की पहचान से जुड़े दायरे में बड़ा बदलाव करने की तैयारी में है। 'हिंदुस्तान' को सूत्रों के जरिए मिली जानकारी के मुताबिक, प्रस्तावित बदलावों को कैबिनेट ने मंजूरी दे दी है। इससे जुड़ा बिल संसद के मौजूदा सत्र में पेश किए जाने की संभावना है। इसके अलावा अंटार्कटिक विधेयक को भी इसी सत्र में पेश करने की मंजूरी दी गई है।

प्रस्तावों के मुताबिक, अब किसी अपराध में शामिल व्यक्ति के बारे में और ज्यादा जानकारियों का दस्तावेज तैयार किया जाएगा। ताकि जांच एजेंसियों को केस सुलझाने में मदद मिल सके तथा अपराधियों को पकड़ा जा सके। अदालतों में अपराध सिद्ध के लिए तमाम सबूतों की जरूरत होती है। ऐसे में आवश्यक साक्ष्य को सुरक्षित करने के लिए कानून में उचित प्रावधान करके जांच एजेंसियों के हाथों को मजबूत करना आवश्यक है।

सूत्रों के अनुसार, कैबिनेट ने 'इंडियन अंटार्कटिक विधेयक-2022' को भी संसद के मौजूदा सत्र में पेश करने की मंजूरी प्रदान कर दी है। इस विधेयक में अंटार्कटिक में कुछ गतिविधियों (जैसे अभियान, जहाज और विमान के प्रवेश के लिए, अंटार्कटिक में भारतीय स्टेशनों में प्रवेश आदि) के लिए परमिट के प्रावधान और कुछ गतिविधियों (जैसे परमाणु विस्फोट, रेडियोधर्मी अपशिष्ट सामग्री का निपटारा आदि) को प्रतिबंधित करने का प्रावधान है।

जिन लोगों की ये माप ली जाएगी उनके लिए किसी अपराध में अपराध सिद्ध होना जरूरी होगा।

अगुस्ता मामला

नई दिल्ली, प्रमुख संवाददाता। अगुस्ता वेस्टलैंड सीदे का फैसला अप्रैल 2014 में इटली की एक अदालत में हुआ था। अदालत ने फैसले में कहा कि अगुस्ता सीदे में घोटाला हुआ था। अदालत ने कंपनी फिनमेकेनिका को दोषी पाया। फिनमेकेनिका की अधीनस्थ कंपनी अगुस्ता वेस्टलैंड के पूर्व सीईओ ब्रूनो स्पैगनोलिन को साढ़े चार साल जेल की सजा सुनाई

गई। अदालत ने भ्रष्टाचार के मामले में कंपनी के एक अन्य अधिकारी ओर्सो को भी सजा दी थी।
