# Modi urges youth: Like Make in India, start wedding revolution

EXPRESSING DISSATISFACTION that India's rich are looking down on holding weddings in their own country and prefer going to other countries for destination weddings, Prime Minister Narendra Modi Friday appealed to the youth to start a 'Wed in India' movement similar to 'Make in India'.

Inaugurating the two-day Uttarakhand Global Investors Summit 2023 at the Forest Research Institute (FRI) Dehradun, Modi urged industrialists and investors to focus on the potential of the middle-class.

Modi also launched Uttarakhand government's 'House of Himalaya' brand and pointed out to the investors that the state has a lot of untapped potential from which they can benefit. This year, the summit's theme is 'Peace to Prosperity'. Even though the guests might not like what he is saying about weddings, he said the country needs a wedding revolution through the 'Wed in India' movement.

"I want to say this to the millionaires and billionaires," he said, "It is believed and said (in our society) that when there is a marriage, God has made that pair. I cannot understand if God is making the pair, why are the couples not starting the journey of their life from the feet of God and going to a foreign country. I want the youths of the country to start the 'Wed in India' movement like 'Make in India'."

"It has become a fashion of our 'dhanna suthi' to get married in other countries. Many people here might look down on it (getting married in India)," he said.

"... Make sure that at least one destination wedding in your family in the next five years takes place in Uttarakhand. Even if just 5,000 marriages take place in Uttarakhand every year, a new infrastructure will develop here, making it a major wedding destination for the world. India has enough strength to make it happen if we decide," Modi added.

"Because of our beneficial schemes, over 13.5 crore people

came out of poverty in five years. These people have given a new speed to the economy," he said.

The PM said there is a need to understand the potential of the middle-class because on one side, the neo middle-class is spending more on their needs while the middle-class is also spending on the things they like.

Congratulating the Uttarakhand government for launching the 'House of Himalaya' brand, he called it a brilliant attempt to establish the local products of the

state in foreign markets which will strengthen the 'vocal for local' campaign. "This is also a matter of my personal satisfaction. Only very few people here might know about my pledge. I have decided over 2 crore village women will be made lakhpati under 'Lakhpati Didi' campaign. This might seem like a tough task, but if the 'House of Himalaya' brand is successful, it will speed up my work," he said.

## CPI Kerala Secy Rajendran dies in Kochi

CPI STATE secretary and former Kerala legislator Kanam Rajendran died on Friday at a hospital in Kochi. He was 73. Over the last two months, he had kept away from active politics due to ill health.

As the leader of the second-largest party in Kerala's ruling Left Democratic Front, Rajendran had been known to take a corrective approach when the Left deviated from its political line. In recent years, he openly criticised the Left government when it slapped the stringent Unlawful Activities (Prevention) Act in a slew of cases, and when police gunned down Maoists.

Rajendran had been CPI state secretary since 2015. He had also served as the national vice-president of the All India Trade Union Congress, the CPI-affiliated trade union, and as member of the central secretariat of the party.

## BJP MLA STARTS NEW STINT WITH A ROW

# Won't take oath with AIMIM leader in Speaker chair: Raja Singh

CONTROVERSIAL BJP MLA T Raja Singh has started his new stint in the Assembly with a row. Elected for the third time from Goshamahal seat, Raja Singh said he won't be taking oath on Saturday, in protest against AIMIM leader Akbaruddin Owaisi being appointed as the Protom Speaker to conduct the proceedings.

"I am not going to take the oath if Akbaruddin is sitting in the Speaker's chair. Akbar is the product of Qasim Razvi, the head of the Nizam's Razakar army, which massacred Telangana people," Raja Singh told *The Indian Express*.

Incidentally, the seven other BJP MLAs elected this time have not raised any such objection, and are set to take oath Saturday.

Governor Tamilisai Soundarajan picked Akbaruddin as the Protom Speaker for being the senior-most legislator in the House,

having won for the sixth time from Chandrayangutta.

Raja Singh's protest is anyway only symbolic as Akbaruddin is to hold the post only for Saturday, with the Speaker to be picked after that. A Protom Speaker is usually appointed to administer the oath of office to newly elected MLAs in the first sitting of the Assembly after an election, and presides over the voting and election of the new Speaker.

The new Speaker is likely to be Gaddam Prasad Kumar, whom the ruling Telangana Congress has nominated. The BJP's tally in the Telangana Assembly has gone up from 1 in 2018 (Raja Singh was the sole winner at the time), to 8, with its vote share doubling from 6.90% to 14%. Raja Singh, 45, had spent 76 days in prison in 2022 after the Telangana Police invoked the Preventive Detention Act against him for repeated offences, particularly for allegedly stoking communal tensions in the city with a controversial video.

## Clean Ganga mission signs pact with Mississippi river initiative
