- Shortlisted Candidate have to bring original & one set self attested photocopy of printed online registration form of apprentice application, all educational qualification documents, Aadhar copy, D.O.B certificate copy, Caste certificate, 05 Passport size color photographs at the time of Interview. If failed to produce the original documents, his/her candidature will be rejected and not allowed to appear in the interview.
- Candidate must have their bank accounts linked with their Aadhar Number.
- AIH&TM (HRD Division of ITDC) have the right to reject the application/candidature at any stage of the selection process. If it is found that the candidate has submitted forge information/documents, his/her candidature will be summarily rejected and he/she will be disqualified.
- No TA/DA will be paid to the candidates for appearing in test/interview.
- During the period of Apprenticeship Training, candidate will be governed by the Apprentice Act 1961(as amended in 1973 & till date) and the policies/rules of ITDC.
- Trade Apprentices will be paid stipend as per the Apprentice Rule.
