Sharad Pawar admitted to hospital with chest infection

NCP (SP) CHIEF Sharad Pawar was rushed from Baramati to a private hospital in Pune on Monday afternoon and admitted for treatment of a chest infection.

Pawar was taken to Ruby Hall Clinic, accompanied by his wife Pratibha Pawar, daughter and Baramati MP Supriya Sule, son-in-law Sadanand Sule, and grandson Rohit Pawar.

"He would be admitted to Ruby Hall Clinic," Kiran Gujar, a family aide, had said earlier.

Dr P K Grant, Managing Trustee, Ruby Hall Clinic, told *The Indian Express*, "We got a call about Sharad Pawar requiring treatment and our medical team has assessed his health condition." He later said Pawar had a slight chest infection and was stable. Doctors at Ruby Hall Clinic said a CT scan revealed slight chest congestion. However, they added Pawar's vital health parameters were stable.

NCP (SP) spokesperson An-kush Kakade said Pawar had been suffering from a persistent cough and was brought to Pune for a check-up. "There's nothing to worry about."

BJP sweeps Maharashtra rural polls; NCP alliance pays off

THE BJP emerged as the leading party in rural areas across Maharashtra in the zilla parishad and panchayat samiti elections, the results of which were declared on Monday, while the two factions of the NCP appear to have benefited from contesting together on a common symbol. The results also indicate Deputy CM Ek-nath Shinde's Shiv Sena has performed significantly better than the Uddhav Thackeray-led Sena faction, making in-roads in rural Maharashtra.

As per data released by the State Election Commission, the BJP emerged as the single largest party, winning 225 of the 731 zilla parishad seats across the 12 dis-

tricts that went to polls. The NCP secured 165 seats, followed closely by Shinde Sena with 162 seats. Among the Opposition, Congress emerged as the largest

party with 55 seats, while Sena (UBT) won 43 seats. The NCP (SP) secured 26 seats.

In 1,462 seats in panchayat samitis where polls were held, BJP won 459, Shinde Sena 302,

significant ground in rural Maharashtra, ahead of Sena UBT's 43 seats. "Outside Mumbai, the organisational space once associated with the undivided Shiv Sena is now largely with us..." a Sena functionary said.

The results have also assumed significance for the NCP, coming weeks after the death of former deputy CM Ajit Pawar, who had pushed for a possible merger. The NCP's decision to fight ZP polls together in Pune and coordinate seat-sharing in at least 10 other districts appears to have helped both factions revive their rural performance, particularly in western Maharashtra, long considered the party's stronghold.

Baba Siddique murder: HC grants bail to accused

THE BOMBAY High Court Monday granted bail to Akash-deep Karaj Singh, one of the accused in the murder of former minister and NCP leader Baba Siddique. Singh was arrested in November 2024 from a border village in Punjab.

Baba Siddique was shot dead on October 12, 2024, outside the office of his son and former MLA Zeeshan Siddique in Bandra (East) by three assail-

ants. Singh approached the Bombay High Court after a sessions court rejected his bail plea on July 19, 2025.

This is the first bail granted to any accused in the Baba Siddique murder case.

"Undoubtedly, the acts committed by the Organised Crime Syndicate, alleged to be headed by Bishnoi brothers, are serious offences. The provisions of the MCOCA are thus invoked. However, on examination of the material relied upon by the prosecution, qua the present

applicant and taking the material against the applicant as it is, without considering the defence of the applicant, I am unable to form an opinion that there are reasonable grounds, at this stage, for believing that the accusations against the applicant of commission of the offence under the MCOCA are prima facie true," the HC noted in its order.

A single-judge bench of Justice Neela K Gokhale granted him bail with several conditions. Singh must report to the

Mumbai police every alternate Monday, cannot leave Maharashtra or the country without the trial court's permission, furnish a personal bond of Rs 1 lakh along with local sureties of the same amount, deposit his passport, attend trial dates unless exempted by the court and share his contact details with the investigating officer, according to the court.

The court clarified that the bail order, issued with "stringent conditions," applies only to Singh.

UK doctor detained at airport: HC to hear plea on Feb 17

THE BOMBAY High Court on Monday said that it will hear on February 17 a plea by a UK-based doctor and YouTuber Sangram Patil challenging an FIR and

Look Out Circular (LOC) issued against him for allegedly posting objectionable content against BJP leaders on social media.

As the matter listed before Justice Ashwin D Bhobe of the high court could not be taken up due to paucity of time, advocate

Ujjwal Kumar Chavhan representing Patil sought urgent hearing citing that UK's citizen's job was at stake due to state action. The judge said he will "make an endeavour" to hear the matter on February 17, a date mutually agreed by the petitioner and the

lawyer representing Mumbai Police. The police, in its affidavit in response to the plea had claimed that probe against Patil was at "critical stage" and "the possibility of an organised effort to malign constitutional authority cannot be ruled out."

मणिपुर : उग्रवादियों ने कई मकानों में आग लगाई

नई दिल्ली, 9 फरवरी।

मणिपुर में एक बार फिर हिंसा भड़क गई है। राज्य के उखरुल जिले में सशस्त्र उग्रवादियों ने कई मकानों में कथित तौर पर आग लगा दी। यह घटना तंगखुल नगा समुदाय के एक सदस्य पर लोगों के एक समूह द्वारा 'हमला' किए जाने के बाद इलाके में तनाव बढ़ने के बीच हुई। अधिकारियों ने सोमवार को बताया कि रविवार शाम को जिले के लितान गांव में

कानून व्यवस्था बनाए रखने और संदिग्ध व्यक्तियों की आवाजाही को रोकने के लिए महादेव, लंबुई और शांगकाई तथा लितान के इलाकों में अतिरिक्त सुरक्षा बल तैनात।

दो आदिवासी समूहों ने पथराव किया, जिसके कारण प्रशासन को निषेधाज्ञा लागू करनी पड़ी।

उन्होंने बताया कि मध्यरात्रि के आसपास लितान सारेइखोंग में तंगखुल नगा समुदाय के कई मकानों में

कथित तौर पर कुकी उग्रवादियों द्वारा आग लगा दी गई। पास के ही एक इलाके में कुकी समुदाय के कुछ लोगों के मकानों को भी जला दिया गया। तंगखुल मणिपुर की सबसे बड़ी नगा जनजाति है। लितान सारेइखोंग कुकी बहुल गांव है। जिले के एक अधिकारी ने कहा कि नुकसान का आकलन किया जा रहा है और स्थिति तनावपूर्ण बनी हुई है। मुख्यमंत्री वाई खेमचंद सिंह ने सोशल मीडिया पर एक पोस्ट में सभी समुदायों से संयम बरतने और शांति बनाए रखने की अपील की। उन्होंने कहा कि आज सुबह मैंने

आरआईएमएस अस्पताल का दौरा किया और उखरुल जिले में हुई दुर्भाग्यपूर्ण लितान घटना में घायल हुए लोगों से मुलाकात की और उनके शीघ्र स्वस्थ होने के लिए सभी आवश्यक चिकित्सा सहायता का आश्वासन दिया। गलतफहमी के कारण हुई इस घटना के बाद हालात अब नियंत्रण में है। मैं सभी समुदायों से संयम बरतने, कानून का पालन करने और शांति एवं सद्भाव बनाए रखने की अपील करता हूँ। सोशल मीडिया पर प्रसारित वीडियो फुटेज में हथियारबंद लोग गांव में मकानों और वाहनों को

आग लगाते हुए और उग्रवादी अत्याधुनिक हथियारों से हवा में गोली चलाते हुए दिखाई दे रहे हैं। अधिकारी ने बताया कि कानून व्यवस्था बनाए रखने और संदिग्ध व्यक्तियों की आवाजाही को रोकने के लिए महादेव, लंबुई और शांगकाई तथा लितान की ओर जाने वाले अन्य क्षेत्रों में अतिरिक्त सुरक्षा कर्मियों को तैनात किया गया है। उन्होंने बताया कि रविवार शाम को सुरक्षा बलों ने लितान सारेइखोंग गांव में आपस में भिड़ें दो आदिवासी समूहों को तितर-बितर करने के लिए आंसू गैस के गोले दागे।

सिक्ंदर बादुशा औलिया दरगाह का मालिकाना हक है। थिरुप्परनकुंद्रम पहाड़ी की तलहटी में भगवान सुब्रमण्य स्वामी का मंदिर है और इस पहाड़ी को भगवान सुब्रमण्य का घर माना जाता है। इसके चलते सनातन धर्म को मानने वाले लोगों के लिए यह पहाड़ी पवित्र है। इस पहाड़ी पर मंदिर के साथ ही एक दरगाह भी है। जिसके चलते यहां नमाज पढ़ने और पशु बलि को लेकर विवाद रहा हो है।

भूमि अधिग्रहण के मुआवजे के खिलाफ अपील पर समय-सीमा कानून की रोक नहीं : न्यायालय

नई दिल्ली, 9 फरवरी (ब्यूरो)।

सुप्रीम कोर्ट ने सोमवार को एक महत्वपूर्ण फैसले में कहा कि भूमि अधिग्रहण के लिए दिए गए मुआवजे के खिलाफ दायर अपीलों परिसीमा अधिनियम के तहत वर्जित नहीं हैं, और हाई कोर्ट ऐसी याचिकाएं दायर करने में हुई देरी को अन्देखा कर सकता है। न्यायमूर्ति एम एम सुंदरेश और न्यायमूर्ति एससी शर्मा की पीठ ने भूमि अधिग्रहण, पुनर्वास और पुनर्स्थापन

अधिनियम, 2013 की धारा 74 को धारा 103 के साथ पढ़ने और परिसीमा अधिनियम 1963 के प्रावधानों के बीच परस्पर संसंध की निर्णय करते हुए इस पेचीदा कानूनी प्रश्न का उत्तर दिया। पीठ ने अहण मामलों की शुरुआत पुराने 1894 के कानून के तहत हुई थी, लेकिन एक जनवरी 2014 को नया कानून लागू होने से पहले जिनमें मुआवजे का कोई निर्णय नहीं हुआ था, उन मामलों में मुआवजा 2013 के नए कानून के अनुसार तय किया जाएगा।

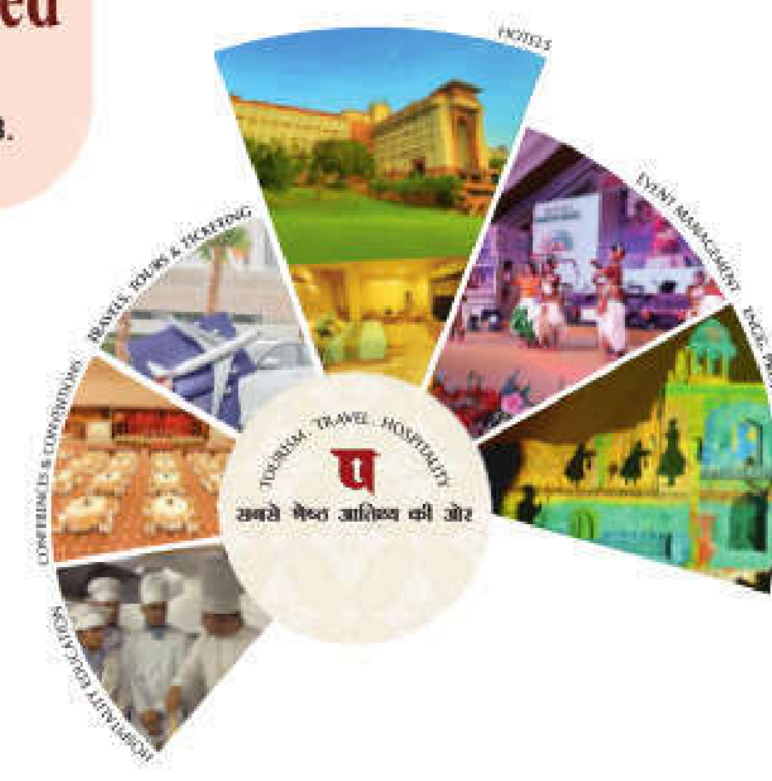
